• NO STICKERS WILL BE ISSUED UNLESS MEMBERS HAVE PAID MEMBERSHIP DUES AND ASSESSMENTS AND HAVE PROVIDED COPIES OF CURRENT VALID STATE REGISTRATIONS. FOR NON-MOTORIZED WATERCRAFT PROOF OF OWNERSHIP MUST BE SUBMITTED (bill of sale).
• A maximum of FIVE (5) stickers will be issued without additional charge upon compliance with the above requirements. ADDITIONAL STICKERS COST 50¢ EACH. If you require additional stickers, please mail your request along with your check to cover the additional amount needed, and copies of registrations for each motor vehicle or craft. (Make check payable to LHPOA, INC.)
• PLEASE REMEMBER—STICKERS ARE NOT TRANSFERABLE. STICKERS ARE FOR THE USE OF LHPOA MEMBERS AND THEIR IMMEDIATE FAMILY MEMBERS WHO ARE DEPENDENT, OR RESIDING WITH THEM. VIOLATION OF RULES CAN RESULT IN SUSPENSION OF YOUR MEMBERSHIP PRIVILEGES.
