Office Report

During the December Board meeting, the Board voted in favor of increasing Building Permits and Resale Certificate Fees as part of the 2023/2024 Fiscal Year Budget. This will take effect on April 1st 2023, the Permit fee will increase to \$35 and the Inspection fee to \$115 (deposit will remain \$250). Resale Certificate fees will be increased from \$75 to \$100.

2023/2024 dues and assessments payments will begin to be accepted on Tuesday, January 3rd. Current stickers are valid until May 2023, new stickers will be available at a later time. To be issued a new sticker, you are must present a valid vehicle/motorboat registration to the office. It has been clarified that moving forward, each member household is entitled to 5 *vehicle* and 5 *boat* stickers before they are charged for any additional stickers.

They have been working to remove any broken limbs that have fallen in rec areas around the lake as well as monitoring LHPOA swails and removing any leaves/debris/sediment found from the rainstorms in December. The speed bump located at the Community Center has been removed.



Lake Heritage Property Owners Association Treasurer's Report

At the December Board meeting the Board approved the Budget for 2023/4. It will take effect from April 1st 2023. The most important part for the majority of Lake Heritage residents is:

"How much are my dues going to be?"

The Bylaws **REQUIRE** that the dues be increased **every year** by a figure that is "no less than the PA CPI (Consumer Price Index) as at December 1. This year's CPI was 7.2%. It was expected to be a higher figure.

The Treasurer shall grant a 3% discount on combined sums of the annual dues and assessments to any member who pays such sum in **full** before April 1 of each year. Members have until 1st May before they are classed as being in arrears, after 1st May all unpaid accounts will be subject to a 15% penalty on the outstanding amount. Accounts not paid by 15th June will result in those accounts being considered delinquent. (LHPOA Rules & Regulations ARTICLE XVI **COLLECTION OF DUES &** ASSESSMENTS)


"What about a payment plan?"

As per the Bylaws, Article XI Dues, Section 2, Paragraph 2.
The Board set the rate of interest on payment plans at 7.2% at the December Board Meeting.

Payroll is the largest operating expense for the Association. All full time positions have been left funded as they currently are.

Services include such things as: Account Services, Legal Services, Landscaping, Cleaning, Dam Inspection, Lake Spot Treatment, Fish Stocking, Newsletter Printing, IT Services, and Software Subscriptions, as well as paying back the Alum Treatment into the Capital Reserves.

Next year will also see funds provided to underwrite the Fireworks for the next 3 years, if donations do not provide enough to cover the cost.

There is money to support Regatta and community engagement will also be support through the revenue raised from newsletter advertising.

The Finance Committee supported the idea of the Association providing funds to support Community Activities and I would like to thank them for the support and work they have provided to me as Treasurer this year and their valuable assistance in delivering this budget for the Association.

A proposal for Capital works was also approved in the budget.



RICH DOOLEY

Have you ever served on a Board of Directors, Trustees or Homeowners Association before? If yes, when and what position(s) did you hold?

I was elected twice and served a total of four years on the board of directors of my local Maryland volunteer fire company in the mid 2000's.

What skills or experience will you bring to the Board of Directors?

I have an extensive background in communication including collegiate study and work in the public sector as The Public Education Specialist for Howard County, MD's fire department. I hope to use these skills to increase the efficacy and timeliness of The Boards interactions with the community. I am also fluent in Robert's Rules of Order due to my time on the fire company's board of directors. We used Robert's Rules to quickly create advantageous actions by the board that benefited the company for many years. If elected, I hope to use my knowledge of Robert's Rules to encourage the same efficiency within Lake Heritage's Board.

If elected, what changes do you hope to bring to the Board and/or the Association?

Over the past few years, we have experienced enhancements in many aspects of The Board. The communication within The Board has improved to a level where the directors can and are in contact with each other every day. If elected, I hope to work with my fellow directors to extend that communication to include the community members as well.

What do you see as the primary responsibilities of the BOD?

I believe there are two primary responsibilities of The Board of Directors:

Harry Buzzerd

Have you ever served on a Board of Directors, Trustees or Homeowners Association before? If yes, when and what position(s) did you hold?

Yes, scores, as board member and as staff—LHPOA, church, college, and associations serving manufacturers and first responder related professional organizations. Positions included elected and chief staff offices.

What skills or experience will you bring to the Board of Directors?

I know associations, Certified Association Executive by American Society of Association Executives 40-plus years; my company, Association and Society Management International, metro-DC, is accredited for ANSI compliance through Association Management Company Institute. Since 1978 purchase of our Lake Heritage property there is incredible change: no longer weekend retreats in casual country setting, now evolved to primary residences of very diverse demographics, a unique recreational suburb of varying needs and wants that require considered and balanced responses. These matured views and experiences enable problem solving with perspectives and trained skills unique for application to LHPOA. Formal training includes B.A., political science and economics, extensive graduate studies three universities—communications and organization management/administration—graduate of U.S. Chamber of Commerce association management institute, and more.

If elected, what changes do you hope to bring to the Board and/or the Association?

We will have a happier and more cohesive community of tolerance through more membership voice and participation. This does not require indentured servitude to a committee or slavish commitment to a cause. Not utilized by LHPOA are many membership recruitment and melding techniques that can provide participation and voice toward shared aspirations. For listing of potentials to overcome communications gaps please refer to the November 10 Organization Design Committee (ODC) presentation to community(available from office). As committee chair I have facilitated design of this blueprint for action, through deliberations of several very qualified and experienced LHPOA members: With a cooperative board and an enthusiastic membership, this involvement/harmonization plan could be institutionalized fully in two years. Another high priority is to deliver to members increased Return On Equity: That means spend more on enhancements and temper budgeting excess dollars to place in reserves—the unknowns of dam/spillway and PA timelines are of such magnitude and flip-flop nature, not even Nostradamus could predict when, what, how much. Therefore, I'm a proponent of spend more now on today's wants and needs, give ourselves a few presents with our money after two years of Covid and years of green, smelly water and a year of administrative turmoil. Time to loosen up and unbuckle the money belt. The organization turmoil of the last year has created a backlog, diversions, from what the Board should have been attending and planning to attend. There is enough reserve money available to gear up for dam/spillway at necessary time, with modest annual cash bumps and with prudent conservative investments (by the Bylaws). The Board needs to accommodate some fundamental recommendations of the ODC(see above mentioned report): Such as document and communicate what is the LHPOA structure, hierarchically and functionally; empower and entrust staff with specific duties; get members out of office administration, an unsustainable business model; think policy and strategically, and design interrelationships from there —staff, Board, committees, members; create community task groups and ad hoc bodies to address special knowledge subject matter, to maximize opportunities and to minimize issues; acknowledge, appreciate, train the safety and security staff, vast majority of whom are our neighbors, members, people who have skin-in-the-game; beef up attention to boating operations, education and enforcement (We are told big brother PA officials are monitoring crowded conditions and inappropriate behavior.); rank order and publish updated priorities; don't rush to fill permanent positions or settle on an overall management system(gaps can be filled temporarily, allowing for occasional inadequacies; continue to improve financial reports(Offer semi-annual community tutorial on what's behind the numbers?) If elected, I will continue to aggressively support thorough approaches for safety and security. Having served as chair of that committee two years. I gained much respect and appreciation for the professionalism of community volunteers and paid staff who truly care for us and for our personal and community property. We have made strides "sharing the road" and there is need to pay increased attention to "sharing the water."

What do you see as the primary responsibilities of the BOD?

I consider much of the above as "primary responsibilities." The lake, the lake, the lake—the money—staff stabilization—champion member voice and involvement—thoroughly consider content of the member survey, not one-and-done and off to bookshelf to collect dust(engage member roundtables to digest the results, create and implement specific response programs and projects.

It's no secret that for decades I have begged more attention to the opening of north end(route 116) to ease cost of gasoline and time of commutes, spread accident potentials, reduce congestion, give the kids another 15-30 minutes sleep, and more. The midpoint of Lake Heritage is Harrison Avenue (get map from office and draw mid-point line): You will see clearly that the majority of homes are on north end of lake. We now have 1,000 vehicles passing daily through current gate, that and Sheetz intersections are not worthy of our needs and our capabilities to improve. At the very least, the Board just must adopt a strategic vision and bellwethers to reach, first step being to obtain formal "seats" on government bodies that have the authority to prioritize north end access combined with reconstruction of bridge bordering our property. Our representatives can collaborate with the planners and decision-makers toward meeting mutual primary needs. Lake Heritage dearly needs both gates, and chips to open them(Stickers are sooo inefficient and costly!) Bottom line primary Board responsibilities are to understand full meaning of the fiduciary oath of office, three basics that have legal implications: Fulfill the DUTIES of Care, Loyalty, and Obedience to LHPOA, the corporation. That carries with it "good business judgment", some elements of which are not in the recent history of the Board. We have lost double digit numbers of employees and key position volunteers in last year. A primary Board responsibility is a turn-around of those numbers and the atmosphere that created the losses. The Board needs to commit to a series of orientation and education sessions as to what it is to be an insightful and effective Board member and perhaps, devote ten minutes each meeting as to what are "best practices" and alternative policies for homeowners associations (This too, could close communications gaps for the community.). Attend the sessions or resign from the Board. (ODC is willing to conduct/coordinate sessions).

What do you love most about living at Lake Heritage?

No longer having to work and survive in the metropolis! One night trip a month to the NoVa business reinforces the joys, conveniences and extraordinary cultural offerings of Adams County. Being on the water, going to the mountains, testing all the restaurants, and watching kids and dogs give great pleasure!

I request your vote to serve as stated above. Thank you.

ALAN KWIATKOWSKI

Have you ever served on a Board of Directors, Trustees or Homeowners Association before? If yes, when and what position(s) did you hold?

Yes, I served as a board member of The Meadows HOA in Carlisle, PA from 2005-2008

What skills or experience will you bring to the Board of Directors?

Not only do I understand that our community consists of a diverse group of individuals, my tenure at the lake has been diverse. I have been a weekender and a year round resident. Times have changed since this community was first established and the By Laws, Rules and Regulations were written or even revised which in some cases are very vague. I feel that we need to look at these documents as a community and possibly bring them up to date with the times we are now living in.

What do you see as the primary responsibilities of the BOD?

I see the primary responsibility of the BOD as a position to be a representative to govern for the members of the association in a fair, equitable, cost effective and sensible manner. I also feel that a Board Member should be a voice for the general membership to the Board of Directors and to the association in general.

What do you love most about living at Lake Heritage?

Lake Heritage is a beautiful community with a lot of wonderful people set in a beautiful location. The current rules and regulations are not as stringent and intrusive unlike the HOA where we used to live and many other HOAs. I especially like when we come together as a community and when neighbors help neighbors.

What else would you like the community to know about you? My wife (Patti) and I have lived at Lake Heritage since September 2018. I am retired from both the military and law enforcement where I served respectively for 21 and 15 years. Patti has a family connection to Gettysburg being the GGG Granddaughter of James and Margaret McKnight who owned the McKnight farm at the intersection of Baltimore St. and Slocum Ave. across from the Evergreen Cemetery. I have always had an interest in Civil War History and especially the battle of Gettysburg. In our spare time we do Civil War Reenacting where I portray a Union Surgeon and do medical talks of that time-period. Patti and I are a blended family with 7 grown children and 6 grandchildren. We are also parents to 5 cats, 4 of which have been adopted from here at Lake Heritage

I graduated from Boiling Springs High School in Boiling Springs, PA in 1975 and attended Harrisburg Area Community College for one year. I have worked in many different fields over the years to include sales, warehousing, manufacturing, food services, pest control, security, and law enforcement. I also served a combined 21 years in both the US Army and PA Army National Guard where I served as a Tank Crewman (4 years) and a Forward Observer with the Field Artillery (17 years) and retired in 2011 as a Staff Sergeant/E-6.

During my military career I held many positions and performed the duties of a tank crewman working my way up to the position of "Gunner" stationed at Ft. Knox, KY and then Mannheim, Germany. While serving as a Forward Observer I performed the duties of platoon Forward Observer, Section Sergeant, Company Fire Support Sergeant and at Brigade level with the 56th Stryker Brigade Combat Team of the 28th Infantry Division as a Fire Support Sergeant working in both the Planning and Current Operations. During our deployment to Iraq (2008-2009) I was assigned as the Fires Cell NCOIC (Non-Commissioned Officer in Charge) in the 56th SBCT TOC (Tactical Operations Center) Current Operations section during the night shift where I helped process and oversaw over 5,000 preplanned and counterfire artillery missions.

I worked in Law Enforcement for 15 years and retired in 2018 as a Federal Police Officer for the Defense Logistics Agency where my duties included enforcement of Federal, State and Local laws, access control of the installation, speed and traffic enforcement, safety and physical security of the Defense Distribution Susquehanna Pennsylvania installation and all personnel. I also served for 3 years as a Field Training Officer for new officers within the department.

Over the past 2 years my wife and I have assisted the Community Engagement Committee (now under the Public Relations & Information Committee) with bringing food trucks to the lake, the Regatta and now with the brush pick-up for those who are unable to take their bush to the drop off site. I am currently working on a project proposal to help improve our recreation areas to make them more accessible and enjoyable for all the members of the community to include more picnic tables, benches, a walking track, and accessibility to these areas for those with mobility issues.

Thank You Ernie Clevinger New Toys for Tots Coordinator!

Lake Heritage is fortunate to have Ernie Clevinger as the new Lake Heritage coordinator for the Toys for Tots program. In the month of December, Lake Heritage residents filled the two boxes at the Community Center with toy donations for this effort.

Ernie reports, "Toys for Tots began in 1947 as the brainchild of Marine Corps Reserve Major Bill Hendricks. Actually, it was his wife, Diane, who was the real inspiration as she had a few handcrafted dolls and asked Bill to deliver them to an agency that supported children in need. When Bill reported back to his wife that he could not find such an organization, she instructed him to "start one!". Maj Hendricks and the Marines in his reserve unit in LA collected and distributed 5,000 toys that year. Presently, the Marine Toys for Tots Program distributes an average of 18 million toys to approximately 7 million less fortunate children annually.

Collecting for Toys for Tots began here in our community in the 1980's. Each year two boxes are placed in the Community Center. Each box holds between 50-75 toys. Most of these toys stay within Adams County, but depending on the need at hand, they can be sent to other counties within Pennsylvania.

Mike Chambers coordinated the program for many years until he moved out of our community. I am the contact going forward. Thank you very much to everyone who continues to support this effort."



TAILS FROM THE FISHING CLUB

DECEMBER 9, 2022 Meeting



Forty-four members and guests gathered on December 9th for our last Fishing Club meeting of the year. Our hosts transformed the Community Center to reflect the evening's theme: "the many blues of the season." Centerpieces, tablecloths, candles, banners and many other decorations offered impressive shades of blue. Two Christmas trees and background music were also enjoyable reminders of the upcoming holidays. Food was plentiful and varied, highlighted by four delicious dishes which included leftover sauce from last month's spaghetti bingo event. President Steve Oakes and Beth Bauer were unable to pick a winner from those dishes, but there were many other "winning dishes" including ham, meat loaf, meatballs, mac and cheese, vegetable casseroles, and salads. No one went home hungry!

Club President Steve Oakes ran the business meeting. Treasurer Ernie Clevinger delivered a two-part presentation. He reviewed the November 2022 financial status (spreadsheets were at each table), reporting \$6,503.26 in funds on hand, including \$976.31 earmarked for the Club's Veterans Initiative. Ernie advised the members of a \$574 commitment in November from the Veteran's Fund. Stan Clark (Adams County Veterans Affairs Office) contacted Scotty Watt to recommend financial assistance for a local veteran in need. Scotty, Steve Oakes, and Ernie all agreed the need was urgent and appropriate for the Fishing Club to assist. The \$574 was provided to help the veteran, who was behind on rent payment. Ernie also summarized the recommended 2023 Fishing Club budget. While most of the major expense lines remain unchanged, small adjustments were made to reflect past expenditure history. The total budget for next year will be \$6,060, down slightly from this year's \$6,285. The Treasurer's monthly report and planned 2023 budget as described were approved by the members.

The Secretary's report of the November 11th meeting was approved by the members, and those with December birthdays and anniversaries were recognized. Our only birthday celebrant received a Lindt's Lindor Truffle, and our married couple (whose anniversary was memorably linked to their daughter's birth) received Little Debbie Christmas Gingerbread Cookies.

Highlights of Old Business: John Spinelli reviewed the origins of the draft Committee Charter for the Club's Veterans Initiative (drafts were provided at both the October and November meetings). He reviewed changes from the "intent" of the Veterans and Members Initiative as described when it was first conceived in 2015/2016, and noted the draft charter would not have prevented any funding commitments previously made by the Club. After some discussion and clarification, the members approved the draft Committee Charter.

A visit by Santa Claus interrupted the New Business discussion. Santa surveyed the members to learn who was naughty and who was nice - his jolly demeanor was enjoyed by all. After Santa departed, Beth Bauer discussed the Family Dinner/Bingo night scheduled in February, 2023. She secured volunteers to make soup and asked all to look for presents to donate - bingo prizes are needed for both kids and adults. In January, Beth will focus on identifying volunteers to support the event (setup, food prep/serving, bingo operation, and cleanup). 
